

Viewing/Inspection for the said motor vehicles will be conducted on July 29 and 30, 2014 in four (4) batches (9:30 a.m. and 1:30 p.m.) for each day.

Pre-Auction Conference shall be open only to interested parties who have purchased the documents. It will be held on July 31, 2014, 1:30 p.m. at the Multi-Purpose Hall, 5th Flr., CTA Bldg. II.


The deadline for the submission of bids/offers shall be on August 13, 2014 at exactly 1:00 p.m. at the CTA Bldg. I Lobby. Late bids shall not be accepted. The Public Auction will immediately follow on the same date at exactly 1:30 p.m. at the Multi-Purpose Hall, 5th Flr., CTA Bldg. II. A bidder can bid for one or more lots, but each lot constitutes a separate sale. No bid shall be lower than the posted minimum/floor price for each lot. All bids must be accompanied by a bid security in the form of Cash or Cashier's/Manager's Check issued by any commercial bank payable to the Court of Tax Appeals in the amount equivalent to ten percent (10%) of the minimum/floor price for each lot. No other form of bid bond/security will be accepted.

The CTA reserves the right to accept or reject any or all of the bids with or without cause, to annul the auction process, to waive any defect therein and to award the bidder whose bid is the most advantageous to the government.
