



INVITATION TO BID FOR

BID PROJECT NO. CTA BAC2-2012-01

Repair of Penthouse/5th Floor, Elevator Machine Room and Roof Deck, and Replacement of Galvanized Iron (G.I.) Roof on Generator Room and Pump Room of CTA Bldg. I

1. The **Court of Tax Appeals (CTA)**, through its Continuing Appropriations intends to apply the sum of **TWO MILLION PESOS (Php2,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for BID PROJECT No. CTA BAC2-2012-01. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **CTA**, now invites bids for the Repair of Penthouse/5th Floor, Elevator Machine Room and Roof Deck, and Replacement of Galvanized Iron (G.I.) Roof on Generator Room and Pump Room of CTA Bldg. I. Completion of the Works is required to be completed within **One Hundred Twenty (120) days**. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the **CTA BAC2 Secretariat**, and inspect the Bidding Documents at the address given below from 8:00 a.m. to 4:30 p.m.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **ONE THOUSAND PESOS (Php1,000.00)**.

Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.


6. The **CTA** will hold a Pre-Bid Conference on **May 8, 2012 at 1:30 p.m.** at the Third Division Courtroom, 2nd Floor, CTA Building II, National Government Center, Diliman, Quezon City, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before **May 22, 2012 at 1:30 p.m.** at Third Division Courtroom, 2nd Floor, CTA Building II, National Government Center, Diliman, Quezon City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.


