INVITATION TO BID FOR
Bid Project No. CTA BAC2-2013-02
Purchase of Two (2) Brand New
Motor Vehicles (Diesel)

1. The Court of Tax Appeals (CTA), through the Continuing Appropriations, intends to apply the sum of **THREE MILLION FOUR HUNDRED THOUSAND PESOS** (Php3,400,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for **BID PROJECT No. CTA BAC2-2013-02** entitled Purchase of Two (2) Brand New Motor Vehicles (Diesel). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Court of Tax Appeals now invites bids for the purchase of two (2) brand new motor vehicles with an ABC of **One Million Seven Hundred Thousand** (Php1,700,000.00) **each**, described as follows:

Lots	Type of Vehicle (Diesel)	Qty.	ABC
A	Passenger Van	One (1) unit	PHP 1,700,000.00
B	Sports Utility Vehicle	One (1) unit	PHP 1,700,000.00

Delivery of the Goods is required on or before thirty (30) days from receipt of Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, A, 5, Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from the CTA Bids and Awards Committee 2 (BAC2) Secretariat and inspect the Bidding Documents at the address given below during 8:00 a.m. to 4:30 p.m.

A complete set of Bidding Documents may be purchased by interested Bidders from June 28, 2013 to July 15, 2013 during office hours from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Five

Thousand Pesos (Php5,000.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

5. The CTA will hold a Pre-Bid Conference on **July 3, 2013 at 10:00 a.m.** at the Third Division Courtroom, 2nd Floor, CTA Building II, National Government Center, Agham Road, Diliman, Quezon City, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. Bids must be delivered to the address below on or before **July 15, 2013 at 10:00 a.m.** All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB Clause 18.1.**



Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address above. Late bids shall not be accepted.

7. The CTA reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.


