

2. Bank draft/guarantee or irrevocable letter of credit issued by a universal or commercial bank - 5% of the total Contract Price or P 157,510.40;

3. If surety bond, callable upon demand, issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security - 30% of the total Contract Price or P945,062.40; or
4. Any combination of the foregoing proportionate to the share of form with respect to total amount of security.


