B. OTHERS:

1. All questions after Pre-bid Conference shall be in writing, addressed to the BAC 1 and submitted at least ten calendar days before the deadline set for the submission and receipt of bids.
2. The word "COMPLY" should be printed on each of the individual parameters of the Technical Specifications; otherwise, the same shall be a ground for disqualification.
3. Certified True Copy (CTC) of the required documents must come from the appropriate issuing government agency. In case CTC is not available at the time of the submission of bids, photocopy is allowed provided that the original copy shall be presented for comparison during the opening of bids.

4. In case of notarization, the proper "proof of identity" should be presented before the Notary Public. Proper notarization is required. Cedula/Community Tax Certificate is not an acceptable proof of identity.

5. In compliance with the deadlines set, the Philippine Standard Time will be the basis.
