## CONTRACT

THIS CONTRACT made on the 10<sup>th</sup> day of July 2015 between the Court of Tax Appeals of the Philippines (hereinafter called "the Entity") of the one part and CARE BEST INTERNATIONAL SECURITY SERVICES, INC. of No. 8428 Camachile Street, San Antonio Village, Makati City, Philippines and duly represented by its President, Mr. Reynaldo M.   - (a) the Bid Form and the Price Schedule submitted by the Bidder;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract;
  - (f) Omnibus Sworn Statement submitted by the Bidder;
  - (g) Certificate of Authority submitted by the Bidder;
  - (h) Entity's Notice of Award; and
  - (i) Performance Security.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.
