CONTRACT

THIS CONTRACT made on the 26th day of October 2016 between the Court of Tax Appeals of the Philippines (hereinafter called "the Entity") of the one part and Eastern Telecommunications Philippines, Inc. of 316 Telecom Plaza, Gil Puyat Avenue, Makati City (hereinafter called "the Supplier") of the other part:

A Statut

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., Procurement of 50 Mbps Dedicated Internet Service and has accepted a Bid by the Supplier for the supply of those goods and services in the total amount of EIGHT HUNDRED SIXTY THOUSAND ONE HUNDRED SIXTY PESOS (P860,160.00) (hereinafter called "the Contract Price").

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

- 1. In this Contract words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Contract, *viz*.:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security;
 - (g) the Entity's Notification of Award;
 - (h) the Omnibus Sworn Statement submitted by the Bidder; and
 - (i) the Certificate of Authority submitted by the Bidder.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants to provide the Entity with the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.
