**CONTRACT**

---

**THIS CONTRACT** made on the 7<sup>th</sup> day of June 2017 between the **COURT OF TAX APPEALS (“CTA”)** of the Philippines (hereinafter called “the Entity”) of the one part and **POWER HOUSE PEST CONTROL SERVICES** of 2422 R. Fernandez Street, Gagalangin, Tondo, Manila, Philippines (hereinafter called “the Supplier”) of the other part:

**WHEREAS** the Entity invited Bids for certain goods and ancillary services, viz., **Provision for General Pest Control in the CTA Compound for Three (3) Years** and has accepted a Bid by the Supplier for the supply of those goods and services in the total amount **ONE HUNDRED FIFTY THOUSAND SEVEN HUNDRED SEVENTY-SEVEN PESOS (PhP150,777.00)** for the first year only, **inclusive of VAT** (hereinafter called “the Contract Price”).

**NOW THIS CONTRACT WITNESSETH AS FOLLOWS:**

1. In this Contract words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Contract, viz.:
  - (a) the Supplier’s Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (*e.g.* bidder’s response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity’s bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the Terms of Reference;
  - (e) the General Conditions of Contract;
  - (f) the Special Conditions of Contract;
  - (g) the Performance Security; and
  - (h) the Entity’s Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.






