This **CONTRACT**, made on this 4th day of October, 2013, in Quezon City, Philippines, between the **COURT OF TAX APPEALS ("CTA")**, created under Republic Act No. 1125, as amended by Republic Act Nos. 9282 and 9503, with principal office address at CTA Building, Agham Road, National Government Center, Diliman, Quezon City (hereinafter called "**the ENTITY**") of the one part; and **TOYOTA MAKATI, INC.** with office address at Ayala corner Metropolitan Avenues, Makati City (hereinafter called "**the SUPPLIER**") of the other part:

WHEREAS, the **ENTITY** invited Bids for certain goods and ancillary services, viz., for the **Purchase of Two (2) Brand New Motor Vehicles (Diesel)**, and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **ONE MILLION FIVE HUNDRED FIFTY SIX THOUSAND PESOS (Php1,556,000.00)** for Lot A – One (1) Unit Passenger Van, and **ONE MILLION FIVE HUNDRED ONE THOUSAND PESOS (Php1,501,000.00)** for Lot B – One (1) Unit Sports Utility Vehicle, or a total sum of **THREE MILLION FIFTY SEVEN THOUSAND PESOS ONLY (Php3,057,000.00)** (herein called the "**CONTRACT PRICE**").

The **ENTITY** hereby covenants to pay the **SUPPLIER** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.


