**CONTRACT FOR THE PURCHASE OF  
ONE (1) BRAND NEW EXECUTIVE VAN (DIESEL)  
Bid Project No. CTA BAC2-2014-03**

This **CONTRACT**, made on this 12<sup>th</sup> day of September, 2014, in Quezon City, Philippines, between the **COURT OF TAX APPEALS** (“**CTA**”), created under Republic Act No. 1125, as amended by Republic Act Nos. 9282 and 9503, with principal office address at CTA Building, National Government Center, Agham Road, Diliman, Quezon City, (hereinafter called “**the ENTITY**”) of the one part; and **TOYOTA MAKATI, INC.**, with office address at Ayala corner Metropolitan Avenues, Makati City 1209, (hereinafter called “**the SUPPLIER**”) of the other part:

**WHEREAS**, the **ENTITY** invited Bids for certain goods and ancillary services, viz., for the **Purchase of One (1) Brand New Executive Van (Diesel)**, and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **ONE MILLION SIX HUNDRED SIXTY-FIVE THOUSAND TWO HUNDRED PESOS (Php1,665,200.00)**, (herein called the “**CONTRACT PRICE**”).

**NOW THIS CONTRACT WITNESSETH AS FOLLOWS:**

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Contract, viz.:
  - (a) the Bid Form and the Price Schedule submitted by the Bidder;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) Bid Bulletin No. 01-2014, dated August 6, 2014;
  - (e) the General Conditions of Contract;
  - (f) the Special Conditions of Contract;
  - (g) Omnibus Sworn Statement submitted by the Bidder;
  - (h) Certificate of Authority dated July 16, 2012 submitted by the Bidder;
  - (i) Secretary's Certificate dated September 30, 2011 submitted by the Bidder;

- (j) Entity's Notice of Award, dated September 2, 2014; and
- (k) Irrevocable Domestic Standby Letter of Credit No. 02026520094144 issued by the Bank of the Philippine Islands on September 8, 2014.

3. In consideration of the payments to be made by the **ENTITY** to the **SUPPLIER** as hereinafter mentioned, the **SUPPLIER** hereby covenants with the **ENTITY** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The **ENTITY** hereby covenants to pay the **SUPPLIER** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.

**IN WITNESS WHEREOF**, the Parties hereto have caused this **CONTRACT** to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


