

RESOLUTION NO. 01-2015

WHEREAS, the Court of Tax Appeals (CTA) had **Bid Project No. CTA BAC2-2015-01 Procurement of Consultancy Services to Undertake Detailed Architectural and Engineering Design for the Proposed Construction of Covered Parking Space, Pathwalk, Perimeter Fence, Main and Pedestrian Gates and Guardhouse** pursuant to the Revised Annual Procurement Plan for Consulting Services CY 2015 and approved Project Procurement Management Plan dated March 25, 2015;

WHEREAS, the CTA has an Approved Budget for the Contract (ABC) in the amount of **FOUR HUNDRED THIRTEEN THOUSAND PESOS (Php413,000.00)** through its Continuing Appropriations, dated September 3, 2014;

WHEREAS, on April 1, 2015, the Request for Expression of Interest for Bid Project No. CTA BAC2-2015-01 was published/advertised in The Philippine Star and posted in the PhilGEPS website, CTA website and in three (3) conspicuous places in the CTA;

WHEREAS, the three (3) invited observers namely: Auditor Milagros M. Torres-Songsong, State Auditor IV, Commission on Audit, CTA Field Office; Engr. Rodolfo Peñalosa, Secretariat President, Confederation of Filipino Consulting Organizations, Inc; and Engr. Eugenio R. Pipo, Jr., National President, Philippine Institute of Civil Engineers, Inc., failed to attend the Opening of Eligibility Documents held on April 7, 2015; at 11:00 a.m.;

WHEREAS, during the scheduled submission and receipt of Request for Expression of Interest and Eligibility Documents on April 7, 2015 at 10:00 a.m., no prospective bidders submitted the Request for Expression of Interest and Eligibility Documents for Bid Project No. CTA BAC2-2015-01 Procurement of Consultancy Services to Undertake Detailed Architectural and Engineering Design for the Proposed Construction of Covered Parking Space, Pathwalk, Perimeter Fence, Main and Pedestrian Gates and Guardhouse;


WHEREAS, in view of the foregoing, the BAC 2 has declared **Failure of Bidding** for Bid Project No CTA BAC2-2015-01 Procurement of Consultancy Services to Undertake Detailed Architectural and Engineering Design for the Proposed Construction of Covered Parking Space, Pathwalk, Perimeter Fence, Main and Pedestrian Gates and Guardhouse, pursuant to Section 35.1 (a) of the Revised Implementing Rules and Regulations of R.A. 9184 otherwise known as the Government Procurement Reform Act.

- 2) To **RECOMMEND** for the approval of the Head of the Procuring Entity (HOPE) for the conduct of a 2nd public bidding for the Procurement of Consultancy Services to Undertake Detailed Architectural and Engineering Design for the Proposed

Construction of Covered Parking Space, Pathwalk, Perimeter Fence, Main and Pedestrian Gates and Guardhouse.


