### B. TERMS AND CONDITIONS

- 1. Bidders shall provide correct and accurate information required in this form.
- 2. Price quotation/s must be valid for a period of Thirty (30) calendar days from the date of submission.
- 3. Price quotation/s, to be denominated in Philippine peso shall include all taxes, duties and/or levies payable.
- 4. Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
- 5. For item Nos. 1, 2 and 3, it shall be delivered within fifteen (15) calendar days from receipt of Purchase Order.
- 6. For item Nos. 4 and 5, it shall be delivered within thirty (30) calendar days from receipt of Purchase Order.
- 7. Payment shall be made within seven (7) calendar days upon installation and testing of the good/s and/or service/s and demand for payment.
- 8. Representatives from the Procurement and Property Management Division (PPMD) and General Services Division (GSD) shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.
- 9. Warranty of the product against inherent factory defects in materials and workmanship shall be three (3) months from Testing and Commissioning. Replacement of defective part/s under warranty shall be seven (7) days upon notice by authorized representative of the Court.
- 10. Liquidated damages equivalent to one tenth of one percent (0.001%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. The CTA shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
- 11. The obligation for the warranty shall be covered by retention money in the amount equivalent to one percent (1%) of the total contract price. The said amount shall only be released after the lapse of the warranty period of three (3) months. Provided, however, that the goods are free from patent and latent defects and all the conditions imposed under the contract have been fully met.
- 12. The CTA reserves the right to accept or reject any offer, to annul the procurement process, and to reject offers at any time prior to award of contract, without thereby incurring any liability to the affected Supplier.
