

Contract Agreement Form

THIS CONTRACT made on the 19th day of December 2014 between the COURT OF TAX APPEALS of the Philippines (hereinafter called "the Entity") of the one part and COLUMBIA TECHNOLOGIES, INC. of 1136-1146 J. Nakpil Street, Malate, Manila, Philippines (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., Ten (10) units of Black & White Printer, Eleven (11) units of Color Printer with Scanner, Forty Six (46) sets of Standard Desktop Computer, Six (6) sets of All-In-One Deskstop Computer, and Seventy Two (72) units of Uninterruptible Power Supply (UPS), and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of THREE MILLION ONE HUNDRED FIFTY THOUSAND TWO HUNDRED EIGHT PESOS (\$\mathbf{P}3\$,150,208.00) (hereinafter called "the Contract Price").

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Contract, viz.:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) Omnibus Sworn Statement submitted by the Bidder;
 - (g) Certificate of Authority submitted by the Bidder;
 - (h) Entity's Notice of Award; and
 - (i) Performance Security.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.

IN WITNESS WHEREOF, the parties hereto have caused this Contract to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
