CONTRACT AGREEMENT
Procurement of Air Conditioning Units

THIS AGREEMENT made on the 20th day of July, 2022 between the **COURT OF TAX APPEALS ("CTA")** created under Republic Act No. 1125, as amended by Republic Act Nos. 9282 and 9503, with principal office address at CTA Building National Government Center, Agham Road, Diliman, Quezon City (hereinafter called "the Entity") represented by **ATTY. DANILO B. FERNANDO** of the one part and **ACMI OFFICE SYSTEMS PHILIPPINES, INC.** with office address at AYSN Building 268-A N. Domingo St., Brgy. Pasadena, San Juan City (hereinafter called "the Supplier") represented by **MS. ROSEMARIE DELA CRUZ** of the other part:

WHEREAS, the Entity invited Bids for the Procurement of Air Conditioning Units (Bid Project No. CTA BAC1-2022-03), and has accepted a Bid by the Supplier for the supply and installation of air conditioning units in the sum of **Three Million One Hundred Forty Thousand Three Hundred Pesos (P3,140,300.00)**, inclusive of all applicable government taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Three Million One Hundred Forty Thousand Three Hundred Pesos (P3,140,300.00)**, inclusive of all applicable government taxes, the Supplier hereby agrees to deliver and install the Air Conditioning Units in the CTA in accordance with its Bid.
 4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
