CONTRACT AGREEMENT

CTA BID PROJECT NO. BAC1-2022-05
“Procurement of Various Furniture and Fixtures”
Lot 1-Procurement of Steel Filing Cabinets

THIS AGREEMENT made on the ____ day of 20 APR 2023 2023 between the **COURT OF TAX APPEALS (“CTA”)** created under Republic Act No. 1125, as amended by Republic Act Nos. 9282 and 9503, with principal office address at CTA Building National Government Center, Agham Road, Diliman, Quezon City (hereinafter called “the Entity”) represented by **ATTY. DANILO B. FERNANDO** of the one part and **ERGO CONTRACTS PHILS., INC.** with office address at Lot 3 Phase 2-B Carmelray Industrial Park, Canlubang, Calamba City, Laguna (hereinafter called “the Supplier”) represented by **MR. CHARLES M. CASTOR** of the other part:

WHEREAS, the Entity invited Bids for Bid Project No. CTABAC1-2022-05 for “Procurement of Various Furniture and Fixtures” divided into Lot 1 and Lot 2, and has accepted the Bid by the Supplier for Lot 1 (Procurement of Steel Filing Cabinets) in the sum of **Four Hundred Forty-Three Thousand Six Hundred Forty-Eight Pesos (₱443,648.00)**, inclusive of all applicable government taxes, for the supply and delivery of the following:

1. Ten (10) units vertical steel filing cabinet with safe;
2. Twelve (12) units lateral steel filing cabinet; and,
3. Five (5) units vertical steel filing cabinet.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - b. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract; and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

- 3. In consideration for the sum of **Four Hundred Forty-Three Thousand Six Hundred Forty-Eight Pesos (P443,648.00)**, inclusive of all applicable government taxes, the Supplier hereby agrees to supply and deliver ten (10) units vertical steel filing cabinet with safe; twelve (12) units lateral steel filing cabinet; and five (5) units vertical steel filing cabinet.
- 4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


