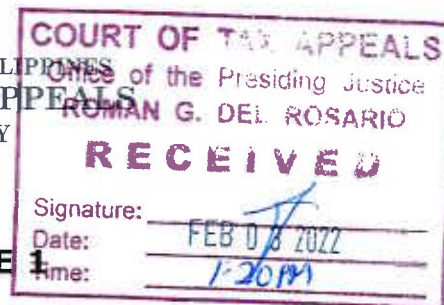

**BIDS AND AWARDS COMMITTEE
(BAC 1)**

RESOLUTION NO. 4-2022

WHEREAS, the Bids and Awards Committee 1 (BAC 1) was created pursuant to Section 11, Article V of Republic Act No. 9184 (otherwise known as the "Government Procurement Reform Act"), as implemented by Section 11, Rule V of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 RIRR of R.A. 9184), reconstituted in accordance with Court of Tax Appeals Administrative Order No. 17-2021, dated July 6, 2021, to conduct public biddings and other procurement projects;

WHEREAS, on January 12, 2022, the BAC 1 conducted the Bid Opening for CTA Bid Project No. CTABAC1-2021-1, "Procurement of Information and Communications Technology (ICT) Equipment";

WHEREAS, only one bidder participated and submitted its bid for LOT A, Quartz Business Products Corporation, and after preliminary examination using the non-discretionary "pass/fail" criterion, the bid was found to have satisfactorily passed the Eligibility and Technical requirements;

WHEREAS, the financial bid of Quartz Business Products Corporation is Four Million Eight Hundred Seventy-Eight Thousand Nine Hundred Sixty-Eight Pesos (₱4,878,968.00) for LOT A which is not in excess of the Approved Budget for the Contract (ABC). Finding that the bid submitted complies with the Eligibility, Technical and Financial requirements of the project, the BAC 1 resolved to submit the bid to a detailed Bid Evaluation;

WHEREAS, on January 18, 2022, the Technical Working Group for ICT Equipment (TWG) submitted a written report showing their detailed evaluation of the eligibility, technical and financial requirements of the lone bidder;

WHEREAS, based on the Evaluation Report of the TWG, it recommended that the Bid of Quartz Business Products Corporation for LOT A be declared as FAILED because of its non-compliance with the technical specifications of the procurement project based on the brochure it provided particularly on the technical specifications of desktop computers on 1) Energy Star Certification and 2) the EPA Certification required for Power Supply;

WHEREAS, on January 19, 2022, the BAC 1 held a meeting to discuss the Evaluation Report submitted by the TWG and during the meeting the BAC 1 agreed with the findings and recommendations of the TWG;

WHEREAS, pursuant to Section 35 of Republic Act (R.A.) No. 9184 as implemented by Section 35.1 (c), Rule X of the 2016 RIRR of R.A. 9184, the BAC shall declare the bidding a failure when all bids fail to comply with all the bid requirements;

NOW, THEREFORE, the members of the Bids and Awards Committee 1 hereby **RESOLVE**, as it is hereby resolved:

1. to declare a Failure of Bidding for Bid Project No. CTABAC1-2021-1, "Procurement of Information and Communications Technology (ICT) Equipment," pursuant to Section 35 of Republic Act (R.A.) No. 9184 as implemented by Section 35.1 (c), Rule X of the 2016 RIRR of R.A. 9184;
2. to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the procurement project to determine the reason of failure of bidding and to recommend to the Head of the Procuring Entity (HoPE) a re-bidding of the procurement project pursuant to Section 35.2 and 35.3 in relation to Section 21.2 of the 2016 RIRR of R. A. 9184.
