### RESOLUTION NO. 06-2017

#### **BID PROJECT NO. CTA BAC2-2017-03** **Procurement of One (1) Unit Brand New Motor Vehicle**

**WHEREAS**, the Court of Tax Appeals (CTA) is conducting a second competitive public bidding for the **Procurement of One (1) Unit Brand New Motor Vehicle** under **Bid Project No. CTA BAC2-2017-03**, pursuant to the approved Revised Annual Procurement Plan for Motor Vehicles, Furniture & Fixtures, Equipment and Books for Fiscal Year 2017;

**WHEREAS**, the CTA has an Approved Budget for the Contract (ABC) dated September 19, 2017, in the amount of **ONE MILLION FIVE HUNDRED THOUSAND PESOS (Php1,500,000.00)** through its Continuing Appropriations;

**WHEREAS**, on **October 24, 2017** the CTA posted the Invitation to Bid for the above-mentioned project in the CTA website, PhilGEPS website, and in conspicuous place in the premises of the CTA;

**WHEREAS**, the BAC2 issued Resolution No. 05-2017 dated October 30, 2017 resetting the deadline for the submission of bids from November 15, 2017 at 11:00 a.m. to **November 16, 2017 at 11:00 a.m.**; and the opening of bids from November 15, 2017 at 11:30 a.m. to **November 16, 2017 at 11:30 a.m.**;

**WHEREAS**, the BAC2 likewise issued Bid Bulletin No. 01-2017 dated October 30, 2017 and was posted in the CTA website, PhilGEPS website, and in conspicuous place in the premises of the CTA;

**WHEREAS**, on October 24, 2017 notices were sent to three (3) invited observers, namely: Auditor Sherelie C. So, State Auditor III and Team Leader, Commission on Audit, CTA Field Office; Mr. Crisanto S. Frianeza, Secretary General, Philippine Chamber of Commerce & Industry; and Mr. Peter Perfecto, Executive Director, Makati Business Club, and on November 2 and 3, 2017 notice of Bid Bulletin No. 01-2017 dated October 30, 2017 were sent to the invited observers;

**WHEREAS**, all the invited observers failed to attend the Pre-bid Conference and Bid Opening held on November 3, 2017 and November 16, 2017, respectively, despite notice;

**WHEREAS**, during the period October 24, 2017 to November 16, 2017 no prospective bidders purchased any bidding documents, as certified by Ms. Soledad R. Ho, Secretariat Head;

**WHEREAS**, on **November 16, 2017 at 11:00 a.m.** no prospective bidders submitted any bidding documents/proposals for Bid Project No. 2017-03 Procurement of One (1) Unit Brand New Motor Vehicle; and

**WHEREAS**, after deliberation by the members of the BAC2 in consultation with the Technical Working Group (TWG) and upon their recommendation, the BAC2 declared a **FAILURE OF BIDDING** for Bid Project No. CTA BAC2-2017-03 Procurement of One (1) Unit Brand New Motor Vehicle on the ground that no bidder submitted bidding documents, pursuant to Section 35.1.a of the 2016 Revised Implementing Rules and Regulations of RA 9184, as amended.


**NOW, THEREFORE**, the BAC2 hereby **RESOLVES** as it is hereby **RESOLVED** to:

- 1) **DECLARE a FAILURE OF BIDDING** for Bid Project No. CTA BAC2-2017-03, Procurement of One (1) Unit Brand New Motor Vehicle; and
- 2) Recommend for another public bidding for the Procurement of One (1) Unit Brand New Motor Vehicle.




