## CTA BIDS AND AWARDS COMMITTEE 2 RESOLUTION NO. 1-2021

## RECOMMENDATION TO AMEND MODE OF PROCUREMENT FOR THE PROVISION FOR THE CONSTRUCTION OF CTA BUILDING III

WHEREAS, the Court of Tax Appeals (CTA) has a procurement project entitled "Provision for the Construction of CTA Building III" in its Annual Procurement Plan (APP), FY 2021, which was approved by the Head of Procuring Entity (HoPE) on January 20, 2021;

WHEREAS, the mode of procurement for the "Provision for the Construction of CTA Building III" in the aforementioned APP is Public Bidding;

WHEREAS, on November 10, 2021, the 2<sup>nd</sup> Executive Committee issued its Resolution No. 2 Series of 2021 (Annex A) wherein it resolved that the construction of CTA Building III be implemented via Agency-to-Agency Arrangement with Department of Public Works and Highways – National Capital Region (DPWH-NCR) thru a Memorandum of Agreement (MOA);

WHEREAS, the 2<sup>nd</sup> Executive Committee resolved further, among others, that the MOA with the DPWH-NCR shall provide that "the approved budget for the Project is 343.5 million *per* 2019 BOQ and Final DUPA, inclusive of the three and half percent (3.5%) Engineering and Administrative Overhead (EAO) to be charged by the DPWH-NCR, subject to adjustment or escalation *via* supplemental MOA upon the final determination of DPWH-NCR;

WHEREAS, Sec. V.D.5.c in the specific guidelines of Annex H of "The 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, Otherwise Known as the Government Procurement Reform Act", as amended, provides that "based on the assessment and recommendation of the End-User unit, the BAC shall issue a Resolution recommending the use of Agency-to-Agency Agreement to the HOPE";

WHEREAS, considering the Resolution No. 2 Series of 2021 of the 2<sup>nd</sup> Executive Committee, as the implementing unit, prescribing that the mode of procurement for the construction of CTA Building III shall be the alternative mode of Negotiated Procurement thru an Agency-to-Agency Arrangement with the DPWH-NCR to be covered by a MOA which, with

suggested revisions, was approved by the Court En Banc in an En Banc Session held on November 24, 2021 (Annex B);

NOW, THEREFORE, the Bids and Awards Committee 2 (BAC 2) RESOLVES, as it is hereby RESOLVED, TO RECOMMEND TO THE HoPE, HON. ROMAN G. DEL ROSARIO, PRESIDING JUSTICE, a change in the mode of procurement for the procurement project entitled "Provision for the Construction of CTA Building III" from Public Bidding to an Agency-to-Agency Arrangement under the alternative mode of Negotiated Procurement.
