## CONTRACT AGREEMENT


### Negotiated Procurement of Bid Project No. CTABAC2-2022-01 for Lot 1 [Three (3) Passenger Vans - Diesel Fed]


THIS AGREEMENT made on the 29<sup>th</sup> day of November, 2022 between the **COURT OF TAX APPEALS ("CTA")** created under Republic Act No. 1125, as amended by Republic Act Nos. 9282 and 9503, with principal office address at CTA Building National Government Center, Agham Road, Diliman, Quezon City (hereinafter called "the Entity") represented by **ATTY. WHEREAS, the Entity invited Request for Quotation (RFQ) for the Negotiated Procurement of Bid Project No. CTABAC2-2022-01 for Lot 1 [Three (3) Passenger Vans - Diesel Fed], and has accepted a price quotation by the Supplier for the supply and delivery of Three (3) Brand New Passenger Vans - Diesel Fed in the sum of **Six Million Five Hundred Sixty-Three Thousand Eight Hundred Eighty-Eight Pesos (P6,563,888.00)**, inclusive of all applicable government taxes.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - I. Invitation for Negotiation dated September 30, 2022;
  - II. Request for Quotation (RFQ) dated October 13, 2022 submitted by the Supplier, including eligibility requirements, Technical and Financial Proposals, and all other documents or statement submitted:
    - i. Schedule of Requirements stated in the RFQ;
    - ii. Technical Specifications stated in the RFQ; and
    - iii. General and Special Terms and Conditions including warranties stated in the RFQ.
  - III. Notice of Award of Contract; and the Supplier's conforme thereto;

- IV. Performance Security; and
- V. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the RFQ. Winning Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **Six Million Five Hundred Sixty-Three Thousand Eight Hundred Eighty-Eight Pesos (P6,563,888.00)**, inclusive of all applicable government taxes, the Supplier hereby agrees to supply and deliver Three (3) Brand New Passenger Vans -Diesel Fed to the CTA in accordance with the submitted RFQ dated October 13, 2022.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms and conditions contained in the submitted RFQ dated October 13, 2022.
