## CONTRACT AGREEMENT

### CTA BID PROJECT NO. BAC1-2022-05 "Procurement of Various Furniture and Fixtures (for Lot 2)"

THIS AGREEMENT made on the day of 20 JUL 2023 between the **COURT OF TAX APPEALS ("CTA")** created under Republic Act No. 1125, as amended by Republic Act Nos. 9282 and 9503, with principal office address at National Government Center, Agham Road, Diliman, Quezon City (hereinafter called "the Entity") represented by **ATTY. DANILO B. FERNANDO** of the one part and **INFINITE QUALITY DESIGNS CENTER, INC.** with office address at (hereinafter called "the Supplier") represented by **MS. GISSELLE AMADOR** of the other part:

WHEREAS, the Entity invited suppliers to submit their best and final offer for the Negotiated Procurement of Bid Project No. CTABAC1-2022-05, "Procurement of Various Furniture and Fixtures (for Lot 2)", and has accepted the quotation by the Supplier for Lots 2.1, 2.5, 2.6 and 2.7 in the total sum of **Five Hundred Eight Thousand Six Hundred Seventy-Three Pesos and Twenty-Nine Centavos (P508,673.29)**, inclusive of all applicable government taxes, for the supply and delivery of the following:

1. Lot 2.1 - Two (2) sets of Executive Table including Side Table, Side Drawer and Mobile Pedestal;
2. Lot 2.5 - Four (4) units Visitor's Chair;
3. Lot 2.6 - Thirty-Two (32) units Conference Chair; and,
4. Lot 2.7 - One (1) set Conference Table including six (6) Conference Chair.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the Updated 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

- a. Invitation for Negotiation dated May 4, 2023;
- b. Request for Quotation (RFQ) dated May 19, 2023 by the Supplier, including eligibility requirements, technical and financial proposals, and all other documents or statement submitted:
  - I. Schedule of Requirements stated in the RFQ;
  - II. Technical Specifications stated in the RFQ;
  - III. General Terms and Conditions including warranties stated in the RFQ.

c. Performance Security;

d. Notice of Award of Contract; and the Bidder's conforme thereto; and

e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **Five Hundred Eight Thousand Six Hundred Seventy-Three Pesos and Twenty-Nine Centavos (P508,673.29)**, inclusive of all applicable government taxes, the Supplier hereby agrees to supply and deliver the following:

Lot 2.1 - Two (2) sets of Executive Table including Side Table, Side Drawer and Mobile Pedestal;

Lot 2.5 - Four (4) units Visitor's Chair;

Lot 2.6 - Thirty-Two (32) units Conference Chair; and,

Lot 2.7 - One (1) set Conference Table including six (6) Conference Chair.

4. The Entity agrees to pay the above-mentioned sum in accordance with the terms and conditions contained in the submitted RFQ dated May 19, 2023.
