 2. The price quotation must be valid for a period of thirty (30) calendar days from the date of submission.
 3. Price quotation, to be denominated in Philippine peso shall include all taxes, duties and/or levies payable.
 4. Quotations exceeding the Approved Budget for the Contract shall be rejected.
 5. Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
 6. Award of contract shall be made to the lowest offer which complies with the technical specifications and terms and conditions stated herein.
 7. The items shall be delivered to the Court of Tax Appeals (CTA) in Quezon City within thirty (30) calendar days from receipt of purchase order. Replacement of defective item/s is within seven (7) calendar days upon delivery.
 8. Representative from the Programs on Awards and Incentives for Service Excellence (PRAISE) and Procurement and Property Management Division (PPMD) shall have the right to inspect and/or to test the goods to confirm their conformity with the technical specifications.
 9. Payment shall be made within seven (7) days upon receipt of the goods and/or services and demand for payment.
 10. The obligation for the warranty shall be covered by retention money in the amount equivalent to one percent (1%) of the total contract price. The said amount shall only be released after the lapse of the warranty period. Provided, however, that the goods are free from patent and latent defects and all the conditions imposed under the contract have been fully met.
 11. Liquidated damages equivalent to one tenth of one percent (0.001) of the value of the goods/services not delivered within the prescribed delivery period shall be imposed per day of delay. The Buyer shall rescind the
