**CONTRACT AGREEMENT**

THIS AGREEMENT made on the \_\_\_\_\_ day of \_\_\_\_\_ 2022 between the **COURT OF TAX APPEALS ("CTA")** created under Republic Act No. 1125, as amended by Republic Act Nos. 9282 and 9503, with principal office address at CTA Building National Government Center, Agham Road, Diliman, Quezon City (hereinafter called "the Entity") represented by **ATTY. DANILO B. FERNANDO** of the one part and **POWER HOUSE PEST CONTROL SERVICES** with office address at 2422 R. Fernandez St., Gagalangin, Tondo, Manila (hereinafter called "the Supplier") represented by **MS. ANNA MARIE M. ESCOBER** of the other part:

WHEREAS, in accordance with the CTA's Revised Annual Procurement Plan for Goods and Services for FY 2021, the Entity requested quotations for the procurement of general pest control and termite control services in the CTA compound for one (1) year through small value procurement (SVP) and has accepted the Offer/Quotation by the Supplier for the supply of those services in the sum of **TWO HUNDRED EIGHTY-TWO THOUSAND SEVEN HUNDRED SEVENTY-SEVEN PESOS (P282,777.00)**, inclusive of all applicable government taxes (hereinafter called "the Contract Price").

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Schedule of Requirements, Technical Specifications, General and Special Terms and Conditions and the Warranties stated in the Request for Quotation No. 18-2021.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Request for Quotation (RFQ) No. 18-2021 submitted by Supplier, including eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
    - i. Schedule of Requirements stated in the RFQ;
    - ii. Technical Specifications stated in the RFQ;
    - iii. General and Special Terms and Conditions including Warranties stated in the RFQ;
  - ii. Notice of Award of Contract; and the Supplier's conforme thereto; and
  - iii. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the RFQ. Winning supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution shall likewise form part of the Contract.
3. In consideration for the sum of **TWO HUNDRED EIGHTY-TWO THOUSAND SEVEN HUNDRED SEVENTY-SEVEN PESOS (P282,777.00)**, inclusive of all applicable government taxes, the Supplier hereby agrees to supply general pest control and

termite control services in the CTA compound for one (1) year in accordance with the Schedule of Requirements, Technical Specifications, General and Special Terms and Conditions and the Warranties stated in the Request for Quotation No. 18-2021.

4. The Entity hereby agrees to pay the above-mentioned sum in accordance with the terms and conditions contained in the Request for Quotation No. 18-2021.
