CONTRACT AGREEMENT

PROCUREMENT FOR RENTAL OF SEVEN (7) UNITS OF PHOTOCOPYING MACHINES

THIS AGREEMENT made on the 23rd day of December, 2022 between the **COURT OF TAX APPEALS (“CTA”)** created under Republic Act No. 1125, as amended by Republic Act Nos. 9282 and 9503, with principal office address at CTA Building National Government Center, Agham Road, Diliman, Quezon City (hereinafter called “the Entity”) represented by **ATTY. DANILO B. FERNANDO** of the one part and **COPIERONLINE PHILIPPINES, INC.** with office address at No. 165 Kamias Road Barangay Sikatuna Village, Quezon City (hereinafter called “the Supplier”) represented by **MR. JOEL B. DELLORO** of the other part:

WHEREAS, in accordance with the CTA’s Revised Annual Procurement Plan for Goods and Services for FY 2022, the Entity requested quotations for the procurement for rental of seven (7) units photocopying machines through small value procurement (SVP) and has accepted the quotation by the Supplier for the supply of rental of seven (7) units photocopying machines in the amount of **Forty-Six centavos (₱0.46) per copy up to a maximum of one (1) million copies or a maximum amount of Four Hundred Sixty Thousand Pesos (₱460,000.00) for one (1) year commencing from January 1, 2023 to December 31, 2023**, inclusive of all applicable government taxes (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Technical Specifications, Terms of Reference and Terms and Conditions, stated in the Request for Quotation No. 19-2022.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Request for Quotation (RFQ) No. 19-2022 submitted by Supplier, including eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - i. Technical Specifications stated in the RFQ;
 - ii. Terms of Reference stated in the RFQ;
 - iii. Terms and Conditions stated in the RFQ;
 - ii. Notice of Award of Contract; and the Supplier’s conforme thereto; and
 - iii. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the RFQ. Winning

supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution shall likewise form part of the Contract.

3. In consideration for the sum of **Forty-Six centavos (₱0.46) per copy up to a maximum of one (1) million copies or a maximum amount of Four Hundred Sixty Thousand Pesos (₱460,000.00)**, inclusive of all applicable government taxes, the Supplier hereby agrees to supply rental of seven (7) units photocopying machines for one (1) year commencing from January 1, 2023 to December 31, 2023 in accordance with the Technical Specifications, Terms of Reference and Terms and Conditions, stated in the Request for Quotation No. 19-2022.
4. The Entity hereby agrees to pay the above-mentioned sum in accordance with the terms and conditions contained in the Request for Quotation No. 19-2022.


