CONTRACT AGREEMENT

THIS AGREEMENT made on the 06 OCT 2023 day of 06 OCT 2023 2023 between the **COURT OF TAX APPEALS ("CTA")** created under Republic Act No. 1125, as amended by Republic Act Nos. 9282 and 9503, with principal office address at CTA Building, National Government Center, Agham Road, Diliman, Quezon City (hereinafter called "the Entity") represented by **ATTY. DANILO B. FERNANDO** of the one part and **U-BIX CORPORATION** with office address at U-BIX Bldg., 1344 Angono St., Makati City (hereinafter called "the Supplier") represented by **MR. JOEY A. FRANCISCO**, as per Secretary Certificate dated August 22, 2023 hereto attached as Annex "A" of the other part;

WHEREAS, in accordance with the CTA's Annual Procurement Plan for Goods and Services for FY 2023, the Entity requested quotations for the **Rental of Seven (7) Units of Photocopying Machine** through small value procurement (SVP) and has accepted the offer/quotation by the Supplier for the supply of the said services in the amount of Seventy-Seven centavos (**₱0.77**) per copy up to a maximum of one (1) million copies or a maximum amount of **SEVEN HUNDRED SEVENTY THOUSAND PESOS (₱770,000.00)** inclusive of all applicable government taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Technical Specifications, Terms of Reference and Terms and Conditions stated in the Request for Quotation No. 28-2023.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Request for Quotation (RFQ) No. 28-2023 submitted by the Supplier, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - i. Technical Specifications stated in the RFQ;
 - ii. Terms of Reference stated in the RFQ;
 - iii. Terms and Conditions stated in the RFQ.
 - b. Notice of Award of Contract; and the Supplier's conforme thereto; and
 - c. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the RFQ. Winning supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution shall likewise form part of the Contract.
3. In consideration of the amount of Seventy-Seven centavos (**₱0.77**) per copy up to a maximum of one (1) million copies or a maximum amount of **SEVEN HUNDRED SEVENTY THOUSAND PESOS (₱770,000.00)**, inclusive of all applicable government taxes, the Supplier hereby agrees to supply all requirements for the Rental of Seven (7) Units of Photocopying Machine in accordance with the Technical Specifications, Terms of Reference and Terms and Conditions stated in the Request for Quotation No. 28-2023.


